Nurses

Our nursing teams are made up of a mix of qualified registered general and paediatric nurses, with a minimum of 3 years post-qualification experience.

Our nurses carry out home visits across a wide range of medical services and work closely with the hospital teams, in accordance with the patient's treatment plan. Each nurse is certified in Basic Life Support (BLS) and trained in the use of emergency medications for anaphylaxis.

All visits are recorded on our electronic patient management system (EPMS). This facilitates the review in real time, of the summary of care report that is sent to the referring teams.



We operate to the highest standards of patient care under the strict guidance of our medical director, clinical nurse managers, clinical pharmacists and our quality team.

Cold Chain Logistics

TCP Homecare provide a complete in-house service of sharps bin management that is registered with the National Waste Collection Permit Office (NWCPO), and carried out by drivers that are all HazChem trained.

The Sharps Bin Waste Management Service includes

- The supply and delivery of Sharps Bins to patients
- The collection and replacement of Sharps Bins from patients once full
- The disposal of the returned Sharps Bins through a licensed waste disposal company
